## Vacancies for Discipline-Specific Education Inspectors of the Councils Education Inspectorate

The SADTC is a statutory authority, established in terms of **Section 2 of Act 19 of 1979** (as amended), to regulate the profession of Dental Technology in the health sector. Our offices are situated in Arcadia Pretoria. Suitably qualified and experienced persons are invited to apply for the four Dental Technology discipline-specific Education Inspector posts (*Prosthetics; Cobalt Chrome; Orthodontics and Crown and Bridge*). The term of office shall be for one-year from the time of appointment.

N.B These appointments are non-salaried positions and only qualify for a daily honorarium, subsistence allowances and travel costs as applicable to members of the Council and/or committees of Council.

Applicants for the appointment as Education Inspectors of the S.A. Dental Technicians Council should comply with the following minimum requirements.

- 1. Must have knowledge and understanding of Act 19 of 1979, as amended, and its associated regulations, specifically pertaining to the education and training of dental technicians and technologists.
- Must be a registered and practising dental technologist/technician or contractor with a sound knowledge of modern dental technology laboratory practice from a minimum of 10 years of current practical experience in a respective disciplinespecific area/s of expertise.
- 3. Must be CPD compliant.
- 4. Must be a graduate from one of the South African Universities of Technology (UoTs), or previously recognised Technikons, offering the programme for the training of dental technicians/technologists, and have a qualification enabling the applicant to register as a dental technologist/laboratory contractor or owner.
- 5. Must be in good standing with the S.A. Dental Technicians Council.
- 6. Must be proficient in English in terms of reading, writing and speaking.
- 7. Must not be employed at any of the training institutions involved in the education and training of dental technicians/technologists or dentists.
- 8. Must not be holding a current position as a moderator and/or external examiner in a Dental Technology training programme at any of the three UoTs.

## **Additional information**:

- 9. Discipline-Specific Education Inspectors of the Council must be prepared to serve in an ex officio capacity on the Dental Technology Liaison Committees at the three UoTs. In particular, advising UoTs on the exit-level examinations and related matters. Each UoT will be responsible for this arrangement, and participation in such committees could take place via video conferencing.
- 10. Reports from each discipline-specific education inspector will be conveyed to the Education Committee of the Council by the Chief Inspector of the Inspectorate.

## Candidates wishing to apply for the above positions are invited to apply by submitting the following:

- 1. A detailed CV, which highlights your current employment information and evidence of your 10 years, or more, experience, in a discipline-specific area/s.
- 2. A certified copy of your Identity Document.
- 3. Your TE and/or LA number.
- **4.** An acknowledgement that there are no cases pending against you nor that you have been convicted of any crime, either civil or prosecuted by the SADTC must be submitted with the application.
