Appointment of the new Council

It is with great pleasure that I announce to you that as of 01 April 2025, a new Council is in place. The Council remains committed to maintaining a culture of good governance, risk management and compliance. I'd like to take this opportunity to welcome the new members to the SADTC family who have been appointed in terms of section 5(1) of the Dental Technicians Act as members of the South African Dental Technicians Council for a five-year term ending on 31 March 2030.

Introducing the new Council

Professor Peter Owen

Prof Owen was re-elected unopposed as the President of the Council to lead the new Council. He is appointed in the category of a dentist as per section 5(1)(e). Prof Owen is an Emeritus Professor and former head of the Department of Oral Rehabilitation in the School of Oral Health Sciences at the University of the Witwatersrand. Prof Owen has been called back by the University of Witwatersrand to act as head of the Dental School. He is a specialist Prosthodontist and is a Fellow of the College of Dentistry of the Colleges of Medicine of South Africa. A global leader in Prosthodontics, he is a past President of the International College of Prosthodontists, the world body for the specialty, and has also served on many different national committees. He has made over 140 presentations locally and internationally and has over 150 publications, including journal papers, books, chapters in books, manuals and other publications. He has been an Associate Editor of the International Journal of Prosthodontics, is a reviewer for a variety of other international journals and is a sub-editor for the South Africa Dental Journal.
